ORDER

The under mentioned candidate advised by the Kerala Public Service Commission for appointment as **NonVocational Teacher in Biology (Jr)** subject to Rule 3(C) of the General Rules in the Kerala State and subordinate service Rules 1958 is provisionally appointed as **Non Vocational Teacher in Biology (Jr)** in the **Scale of Pay of Rs 9190-15510 (PR)** in the Department under Rule 9 (a) (i) of the General Rules in the K.S. and S.S Rules, 1958. The provisional appointment is also subject to the conditions laid down in the G.O., read as 2nd paper above that the appointment shall be terminated without notice if Government is not satisfied of the character and antecedents of the candidate. He /She will be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification and the receipt of the report of verification by KPSC as ordered in the G.O. 6th cited. The candidate are posted in the institution noted against his/her name **Subject to the condition that he/she will be posted to another school if a NVT in Biology (Jr) now in Service requests for transfer to that school in the General Transfer 2016-2017.**


2. The candidates is directed to report for duty before the Head of Institutions concerned with documents in original to prove qualifications, date of birth, community etc. and a health certificate as contemplated under Rule 13 of part I K.S.R. on the reopening date of Schools in the academic year 2016-2017 or before 10/06/2016 failing which their appointment are liable to be cancelled without further notice.
3. The candidate is also informed that in the event of discharge from service for want of vacancies he/she may re-register their name in the office of Public Service Commission from where they was advised and got him selves re-appointed on further advised by the Public Service Commission or they may wait for his turn for re-appointment to the post in the department in case they desires to continue as probationer in the post from which they was discharged.
4. The Head of the Institution will admit the candidate only after verifying the particulars regarding qualifications, date of birth, Community, Non Creamy Layer Certificate (in the case of reservation candidates only) etc. in original and report the date of joining duty without fail.
5. The Head of the Institution will also obtain the necessary details of the candidate duly filled up in the prescribed proforma as required in the G.O., read as 3rd paper above, before the candidate are admitted to duty and forward the same to this office, so as to enable this office to make necessary arrangements for the verification of character and antecedents of the candidate.
6. The photograph and signature of the candidate may be verified and the fact recorded by the Head of Institution in the identification certificate after the candidate is allowed to join duty.
7. Physical fitness certificate vide G.O. (P) No.20/2011/P&ARD dated 30-6-2011 obtained from each candidate before appointment, from a Medical Officer not below the rank of as Assistant Surgeon should be produced at the time of joining duty duly affixing the photograph and thump impression of the candidate and got attested by the Medical Officer.
8. The Service Book of the incumbent should be opened within a week and forward the attested copies of the pages including Name and Address ,Signature ,Thump Impression , Identification Marks and copy of the IC to the Director of VHSE.
9. The KPSC will return the photograph with thump impression to the appointing authority after conducting an interview with the employee and confirmation of the information's.
10. The candidate is directed to forward two copies of application for obtaining PRAN to the concerned Assistant Director , Regional Office ,VHSE , through the Head of institution forthwith.
