Memorandum

Subject: Recruitment to the post of Research Assistant (Botany) (DR quota)

In terms of Bye law No. 25(b) of the Central Council for Research in Siddha, the Director General, offers the post of Research Assistant (Botany), initially on a temporary basis, in the **Siddha Central Research Institute, Chennai** in the pay scale of PB 2 (Rs 9300-34800) + GP Rs 4200 to **Smt. RUBEENA.M** on the terms and conditions as under:

- 1) The appointee will be on probation for a period of two years which may be extended at the discretion of the competent authority. The appointment is liable to be terminated at any time without notice and without assigning any reason(s) during the period of probation and thereafter on one month's notice and without assigning any reason(s) given by either side. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith before the expiry of notice period by making payment to the appointee a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- 2) The benefit of new restructured defined contributory pension scheme is admissible as per the provisions contained in the Department of Economic Affairs' Notification No. 5/7/2003- ECB&PR dated 22.12.2003 effective from 1.1.2004.
- 3) During probation the appointee will be required to undergo such training as may be considered necessary and to pass such tests and complete the probation period satisfactorily, failing which his services shall be terminated.
- 4) The appointment carries with it the liability to serve anywhere in India
- 5) The appointee will have to take an oath of allegiance and faithfulness to the Constitution of India (or make affirmation to that effect) in the prescribed form.
- 6) The appointee will submit a declaration in the prescribed form in regard to the marital status.
- 7) The appointee will have to produce original certificates of age and educational qualification and the community certificate issued by the competent authority. He/She will also have to produce a certificate in original in support of his/her claim of belonging to a Scheduled Caste or Scheduled Tribe or Other Backward community, if applicable.

2. The appointment is provisional and is subject to the caste certificate, if applicable, being verified through the proper channels. If the verification reveals that the claim of the candidate is found to be false, his/her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

3. If any declaration given or information furnished by him/her proves to be false or if he/she is found to have willfully or deliberately suppressed any material information, he/she will be liable to removal from the Government service by the competent authority.


4. Other conditions of service will be governed by the Central Government Rules and orders in force from time to time applicable to the officials of his/her class.

5. Further the appointment is **provisional** and will be subject to –

(a) verification of character and antecedents by the Competent Authority of the appointee in terms of DoPT's Office Memorandum No. 18011/2(s)/2016-Estt.B(i) dated 29.06.2016; in case character & antecedents of the candidate is found not verified or any false information is given by the candidate in his/her self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken, as a consequence.

(b) submission of medical certificate of fitness from a Medical Examination Board of a District Government Hospital, within a period of two months from the date of joining.


