MEMORANDUM

Consequent upon selection on the basis of online written examination held during the month of December, 2019, I am pleased to convey the approval of Director General, Central Council for Research in Ayurvedic Sciences (CCRAS), New Delhi for issuance of an offer of appointment to **Mr. Nikhil Krishna (SC) (DOB: 07.03.1992)** for a temporary post of **Research Assistant (Botany) at Regional Ayurveda Research Centre, CMO Building, District Hospital Colony, Dimapur, Nagaland – 797112 under this Council on a pay of Pay Matrix Level-6 of Rs. 35400-112400 (Pay Band 2, Rs.9300-34800 plus Grade Pay Rs.4200/- as per VI CPC) per month.** The appointee will also be entitled to draw dearness and other allowances at the rates admissible and subject to the conditions laid down in rules and Orders governing the grant of such allowances in force from time to time.


2. The appointment is subject to the following conditions:-

i. The appointment is purely provisional subject to satisfactory police verification and satisfactory verification of all eligibility testimonials from the respective certificate issuing authorities.

ii. The appointment to the post is temporary until further orders. The appointee will be on probation for a period of two years from the date of joining the post. The period of probation may, however, be extended at the discretion of the Appointing Authority. During this period, the appointment can be terminated at any time without notice, notwithstanding the provisions under clause (iii) below, if you are otherwise found ineligible or unsuitable for further retention in the service under Central Civil Services (Temporary Service) Rules, 1965.

iii. The appointment may be terminated at any time by a month's notice given by either side viz., the appointee or the appointing authority subject to other terms and conditions prescribed under Government instructions under CCS (TS) Rules, 1965. The Council, however, reserves the right of terminating the service of the appointee forthwith or before the expiration of the stipulated period of notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the un-expired portion thereof.

10. If Mr. Nikhil Krishna accepts the offer on the above terms, he should report Asstt Director, Institute In Charge, Regional Ayurveda Research Centre, Building, District Hospital Colony, Dimapur, Nagaland - 797112 within 30 days from the issue of this memorandum along with all original certificates/documents/testimonials of eligibility for the above said post in the following:
- (i) attestation form duly filled in by him/her in triplicate and attested by a first class Magistrate/Senior Class-I Officer to the Government of India (specimen enclosed).
 - (ii) Medical fitness certificate duly issued by your Chief Medical Officer/District Hospital Officer (letter is attached).
 - (iii) Character certificate duly issued by first class Magistrate/SDM (specimen attached).
 - (iv) Oath of allegiance form duly filled, (Specimen attached).
 - (v) Marital status certificate duly filled in, (Specimen attached).
 - (vi) Further he/she is required to execute a bond on non-judicial stamp paper valuing Rs. 100/- mentioning that the documents submitted are true and correct as per his/her knowledge and if found to be false/fake/or not in conformity with laid down eligibility criteria as contained in the advertisement pertaining to all eligibility conditions, his/her candidature will be rejected by this council and if such a misconduct comes to the notice of the appointing authority after appointment, he/she can be removed/dismissed from service and he/she will be liable for criminal/legal prosecution as deemed appropriate by CCRAS. 11. If no reply is received or the candidate fails to report for duty by the prescribed date, the offer will be treated as cancelled without any further intimation.
12. No travelling allowance will be allowed for joining the appointment.
