ORDER

As per paper read as first above, applications were invited from qualified candidates for appointment to the post of Assistant Professors in various teaching departments of the University.

2. As per paper read as second above, the Syndicate held on 30.01.2021 resolved to approve the reservation roster as mandated by KS&SSR ,applied against each arising vacancy, to the post of Assistant Professors ,complying the High Court order in WP(C) No(s) 9785 of 2015-W,17961 of 2015-U,18659 of 2015-F and 18797 of 2015-Y dated 03.02.2016.

3. As per paper read as third above, the Syndicate considered the recommendation of the Selection Committee for the post of Assistant Professor (Permanent) in the Department of Botany and resolved to approve the ranklist. Further resolved to appoint Smt.Deepna Latha.K.P against the vacancy reserved for Viswakarma (Permanent),Smt.Resmi.L against the Open (Permanent) vacancy and Sri.Pramod.C against the vacancy reserved for ETB (Permanent) in the Department of Botany,subject to the final disposal of petitions pending against the proceedings pursuant to Notification No GAI/C1/156687/2019/Admn dated 31.12.2019 before the Honourable High Court of Kerala.

4. As per paper read as fourth above, Dr.Deepna Latha.K.P. was informed that she has been selected for appointment as Assistant Professor (Level 10) in the Department of Botany against the permanent vacancy reserved for Viswakarma with a direction to report before the Registrar within a period of 15 days.

5. As per paper read as fifth, Dr.Deepna Latha.K.P. has joined duty w.e.f 17.02.2021.F.N. She has produced a Medical Fitness Certificate as contemplated under Rule 13 Part I KSR. Her Original Certificates have been verified and found correct.

6. Under the above circumstances, sanction has been accorded by the Vice-Chancellor to appoint Dr.Deepna Latha.K.P. as Assistant Professor (Level 10) in the Department of Botany, against the Permanent vacancy reserved for Viswakarma w.e.f 17.02.2021.F.N. The above appointment is governed by the relevant provisions of Calicut University Act and Statutes. Dr.Deepna Latha.K.P will be on probation for a period of one year within a continuous period of two years. The pension scheme applicable to the individual will be contributory pension scheme but those who are enjoying Statutory Pension in the prior service before joining the Calicut University Service will be eligible for the continuance of the Statutory Pension Scheme. The appointment will be subject to the final disposal of cases regarding the recruitment before the Honourable High Court of Kerala. The appointment is

purely temporary and she will be terminated as and when the vacancy ceases to exist.

7.The expenditure on this account will be met from the Head of Account Part I - Non-plan -Expenditure 09-2000-01 Staff salary/Remuneration (Teaching) of the current year's budget.
